Throckmorton County Commissioners' Court met in Regular Session on Monday the 12th day of January 2026 at 9:00 a.m., at 105 North Minter, Throckmorton, Texas, with the following members present:

1. Caleb Hodges called the meeting to order at 9:00 am and welcomed all guest.
