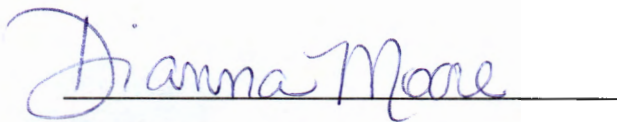

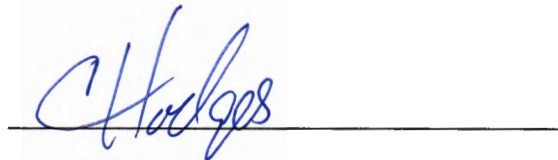
Others present: Michelle Clark, Glen Whitfield, Kirby Gober, Karla Benson, and Nathan Lemons
