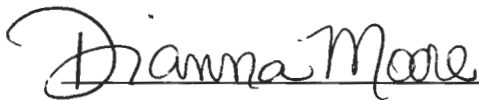

1. Caleb Hodges called the meeting to order at 9:00 am and welcomed all guests. Commissioner Wells was absent.
2. Minutes from the previous meeting were reviewed. Kasey Hibbitts made the motion with Greg Brockman seconding to approve the minutes. Motion carried 4-0.
