


Others present: Michelle Clark and Bobby Thompson

1. Caleb Hodges called the meeting to order at 9:00 am and welcomed all guest.
2. Minutes from the previous meeting were reviewed. Kasey Hibbitts made the motion with Klay Mitchell seconding to approve the minutes. Motion carried 5-0.
3. No action
4. Citizen's Comments: No comments.
5. Klay Mitchell made the motion with Casey Wells seconding to canvas the 2026 Primary Election Results. Motion carried 5-0.
6. Klay Mitchell made the motion with Kasey Hibbitts seconding to approve the purchase of a 2021 John Deere 672 G Road Grader for Precinct 2 and that Caleb Hodges and Kasey Hibbitts will discuss everything needed to finance Road Grader. Motion carried 5-0.
7. Caleb Hodges made the motion with Greg Brockman seconding to approve the 2026 Equipment Charges with no changes from 2025. Motion carried 5-0.
8. Elected Officials Report: Caleb Hodges reported that he met with the District Judge, District Attorney, and County Attorney regarding some changes after this year due to some retiring. He also stated that we will be having a jury trial this summer that is possibly going to require an expert witness and what it will cost the county for one, which will be around \$15,000 - \$20,000.
