
1. Trey Carrington called meeting to order at 9:05 A.M. and welcomed guest.
2. Dianna Moore read the minutes from the previous meeting. Klay Mitchell made the motion with Kasey Hibbitts seconding to approve the minutes. Motion carried 5-0.
3. Kirby Gober presented the Hospital report and bills to the court. The Hospital board approved the bills in the amount of \$243,041.99. The bills are a little higher due to the board met early one month and late the next and also had 2 months of physician's pay. Kirby also requested the \$200,000.00 county subsidy. Trey Carrington made the motion with Kasey Hibbitts seconding to approve the hospital report, pay the bills, and to give them the county subsidy. Motion carried 5-0.
4. Citizen's Comments: No comments.
5. Casey Wells made the motion with Greg Brockman seconding to Canvass the November 2022 General Election. Motion carried 5-0.
6. Klay Mitchell made the motion with Kasey Hibbitts seconding to approve the bond on James Wells. Motion carried 5-0.

8. Klay Mitchell made the motion with Kasey Hibbitts seconding to accept the resignation letter from Paul Allen as the Throckmorton County Veteran's Officer. The letter is attached. Motion carried 5-0.

10. Klay Mitchell made the motion with Kasey Hibbitts to reappoint all the board members except for Linda Perry. ^{Throckmorton Historical} The board members are as followed: Trent McKnight, Brad Bellah, Mike Martinson, Judy McClymont, Rhonda Riley, and Ray Fowler. Motion carried 5-0.
11. No action on line item 11, will discuss more at a later date.
12. Klay Mitchell made the motion with Kasey Hibbitts seconding to adopt a special budget for unexpected funds received in 2022 in the amount of \$893,378.00. Discussion was held on dividing \$200,000.00 of the monies between precincts, which will be \$25,000.00 to PCT 1, \$50,000.00 to PCT 2, \$100,000.00 to PCT 3, and \$25,000.00 to PCT 4 and was approved. Motion carried 5-0.
13. Elected Official's Report: Doc's report is attached.
14. Brenda Rankin presented the bills to the court. Klay Mitchell made the motion with Kasey Hibbitts seconding to approve and pay the bills. Motion carried 5-0.
15. Casey Wells made the motion and seconded by Greg Brockman to adjourn at 10:37 a.m. Motion carried 5-0.
