Throckmorton County Commissioners' Court met in Regular Session on Tuesday the 14th day of October 2025 at 9:00 a.m., at 105 North Minter, Throckmorton, Texas, with the following members present:

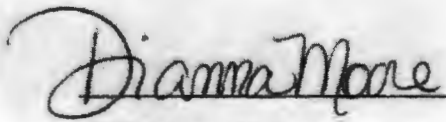

1. Caleb Hodges called the meeting to order at 9:00 am and welcomed all guest.
2. Minutes from the previous meeting were reviewed. Klay Mitchell made the motion with Greg Brockman seconding to approve the minutes. Motion carried 5-0.
3. Kirby Gober presented the Hospital bills and report to the court. Mr. Gober stated that the board approved the bills in the amount of \$490,566.39. Caleb Hodges made the motion with Klay Mitchell seconding to approve the report and pay the bills. Motion carried 5-0.
4. Citizen's Comments: No comments.
5. Ty Jordan, Throckmorton County Extension Agent gave a report to the Court on the 4H kids. They did well in the Abilene competition. No action taken.
6. Casey Wells made the motion with Kasey Hibbitts seconding to authorize Michelle Clark, County Treasurer, to open a new account with InterBank titled Throckmorton County Sheriff DMV and designating Glen H. Whitfield, Throckmorton County Sheriff, Ryleigh E. Frank, Administrative Assistant, and Michelle Clark, County Treasurer, as authorized signers on the account. Motion carried 5-0.
7. Klay Mitchell made the motion with Casey Wells seconding to adopt the Throckmorton County Resolution Indigent Defense Grant Program. See attached. Motion carried 5-0.
8. Casey Wells made the motion with Greg Brockman seconding to purchase ballistic shields for the Sheriff's Office using SB22 funds. Motion carried 5-0.
9. Casey Wells made the motion with Kasey Hibbitts seconding to place a county wide Burn Ban to go into effect October 14, 2025, and expire on January 6, 2026. Motion carried 5-0.
10. Elected Officials Report: Casey Wells stated that he spoke to Mark Fare about Treasury Bonds for funds. He also stated that the Commissioners would be at school next week. Caleb Hodges stated that he got a call from the city regarding the water at the Community Garden at the Museum and that the City wants to know if the County can help with the road on Pine St. and that he would get with Jimmy on the details. Caleb also stated that he would like to use the money from the Tobacco Settlement to help the clinic.
11. Michelle Clark presented the bills to the court. Caleb Hodges made the motion with Kasey Hibbitts seconding to pay the bills. Motion carried 5-0.
12. No Executive Session
13. Casey Wells made the motion and seconded by Greg Brockman to adjourn at 9:33 a.m. Motion carried 5-0.
