
Others present: Brenda Rankin, Caleb Hodges, Bobby Thompson, Nancy Johnson, Bryan Key, and Doc Wigington

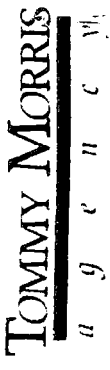
